The ACCA route

Want to become a trusted business adviser? Looking to gain a professional qualification right away? University not for you?

Enjoy 3 years of studying, learning and gaining real work experience, working with organisations of all shapes and sizes across a variety of sectors. If you join us straight after your A-levels you could become a fully qualified ACCA (Association of Chartered Certified Accountants) associate in just 3 years.

It works like this: Grant Thornton will pay for all your tuition (we are partnered with reputable and professional ACCA tuition providers), exam fees and study materials. You will initially work 20 hours per week to gain a precious and rewarding work experience. You will also attend lectures, study and sit for the ACCA examinations. Grant Thornton will also pay you a salary, a study grant and you will be entitled to paid study leave for every subject that you attempt. There are currently 13 modules making up the entire ACCA qualification. 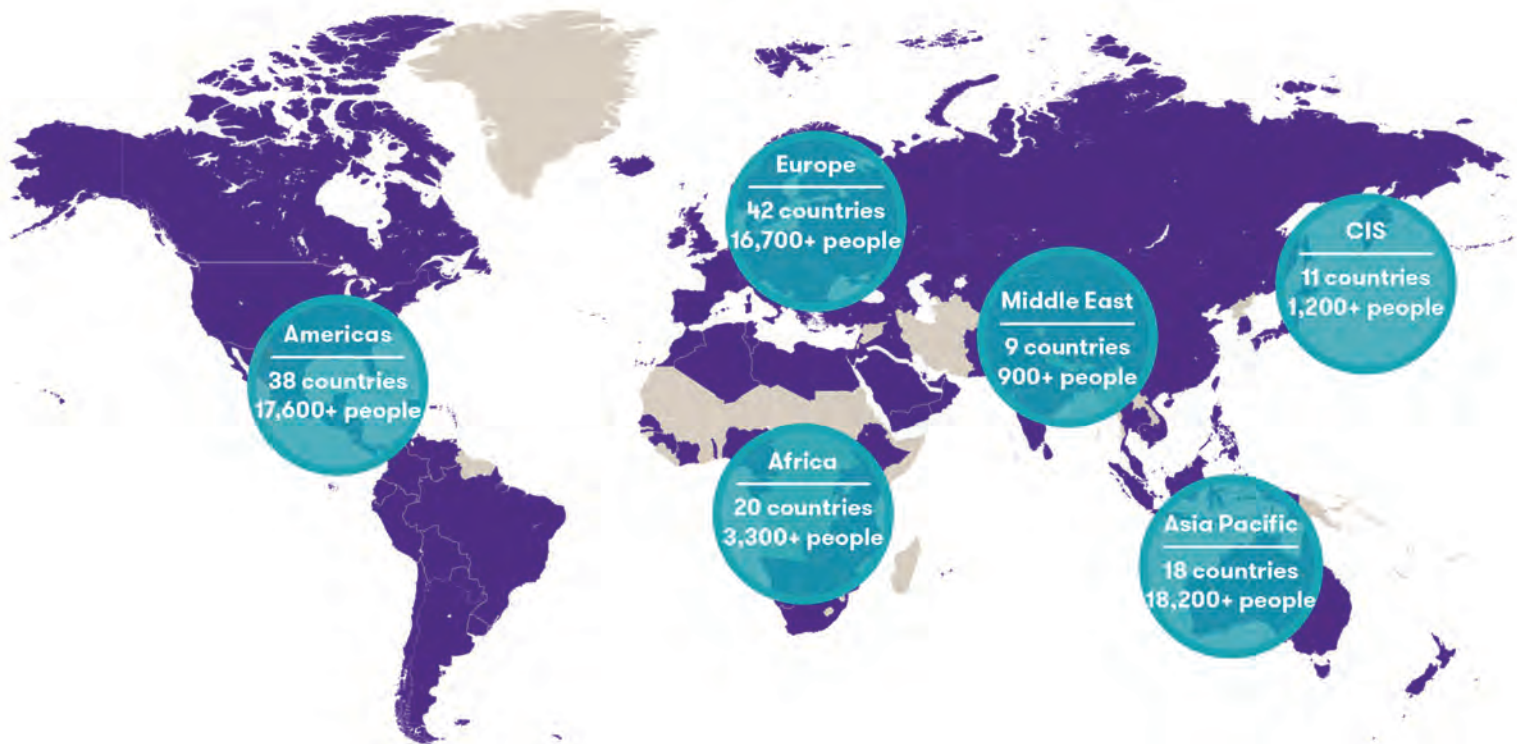
